

# WCRA HAMFEST FLEA MARKET INFORMATION

Re: Flea Market Table Reservations



Thank you for your interest in the WCRA Hamfest. **The 2008 Hamfest will be held on Sunday, January 27, 2008 at the DuPage Expo Center, 4050 E. Main Street, St. Charles, IL 60174.** This is the same facility, located across the street from the Pheasant Run Mega Center, which we used last year.

Prices for flea market tables are \$25 per table. A limited number of electric power drops will be available, for a flat fee of \$25.00 in addition to the cost of the tables. Wall tables are reserved for commercial vendors at a higher rate. If you desire wall tables, please let us know and we will be in contact with you on rates.

Move in is permitted 6 p.m. to 10 p.m. Saturday night, and 5:00 a.m. thru 7:30 a.m. Sunday morning. The facility will be locked down from 10 p.m. Saturday night thru 5:00 a.m. Sunday. If you require access to move in between 10 p.m. and midnight on Saturday, please contact us. The doors open to the public at 8 a.m.

Table assignments will again be made on a best-utilized basis with preference being given to repeat vendors. In order to assure that requests for space are honored, they must be received no later than December 31, 2007 with the appropriate fee for tables and tickets. As always, we are not able to accommodate everyone's special requests, but we will attempt to work with you to address your needs. Please note any special requests on the registration form and submit it as soon as possible so that we have adequate time to address your issues. If you wish to be located adjacent to another vendor, we recommend submitting the requests at the same time noting your desire. Separate forms and checks can be used for this purpose. We will notify you by postcard, phone or email upon receipt of your registration.

As in the past, a limited number of handcarts will be available to assist with move-in and move-out. We do, however, recommend that you bring your own carts if possible to expedite the process. Final table assignment and information regarding move-in and setup will be sent to you after January 14, 2008. Please do not call for information prior to that date. **You will not be permitted to drive into the buildings.**

Only tickets purchased with your table reservations will allow entry to the facility prior to 8 a.m. No early entry tickets will be available for sale the morning of the Hamfest. We reserve the right to limit the number of tickets purchased with each table. Everyone age 12 and older must have an admission ticket. In order to provide a safe environment for the attendees, Vendor move out will not begin until the show has closed to the public at 1 p.m. Prior to that time, vendors may use the public exits, but the use of carts will be prohibited until 1:00 p.m. Sunday.

Please remember that this is a family event, and we therefore forbid the display of, advertisement of, or sale of pornographic / adult goods at our hamfest. We reserve the right to, at the discretion of any hamfest committee member, immediately terminate contract, without refund of table fees or entrance fees, with any persons or vendor(s) failing to comply with this requirement, with or without cause. Failure to comply may also result in vendors and / or individuals being barred from attending future WCRA hamfest events.

Enclosed is a reservation form for your use. Mail the registration form to Mr. Robert Krueger, 2 S. 250 Valley Rd., Lombard, IL 60148, as soon as possible. All reservations must be accompanied by a #10 SASE with sufficient postage for the number of tickets you are ordering and by your check or money order for the appropriate amount payable to WCRA. Table reservation won't be made until the check and SASE arrive.

We look forward to seeing you on January 27.
